

MUSEUM OF THE MOVING IMAGE

RIGHTS AND PERMISSIONS POLICY FOR IMAGES

Images from the collection of the Museum of the Moving Image (the Museum) may not be reproduced without prior written permission from the Collections Department. By accepting the image(s) supplied by the Museum, you agree to abide by the following terms and conditions:

1. You will secure any and all necessary permissions from persons, corporations, or other legal entities which may own or claim any proprietary rights whatsoever under statutory or common law in or to the images, and to pay any and all fees for reproduction of copyrighted materials. You are held fully responsible for compliance with or infringement of copyright and similar restrictions.
2. You will hold the Museum harmless from any action involving or arising from any claim relating to the infringement or alleged infringement of the rights of an author, illustrator, photographer, creator, or his or her heirs or descendants, representatives, agents, designees, and/or subsequent copyright holders in common law or under statutory copyright. The Museum makes no representation, express or implied, that it claims or possesses any such rights or the power to convey such rights to a third party.
3. You will use the credit line "Museum of the Moving Image" with each image. This credit line must appear with printed matter under or adjacent to the image on the same page, or on page facing the image. With films, videotapes, broadcasts, CD-ROM products, videodiscs, and other moving image media, the required credit line must appear with other "Sources of Illustrations." Whenever possible, the image number provided (and the photographer's name, if provided) should be included in the credit line. Acknowledgment of donor and/or creator will be made when appropriate.
4. Any reproduction of the image(s) shall be solely for the use described in your duly submitted letter of request. Images may not be reused in a subsequent edition or in any other format without the Museum's express written consent and payment of additional fees.
5. Images furnished by the Museum may not be cropped, manipulated, overprinted, toned, silhouetted, bled, or altered in any way without prior written permission from the Museum. Requests must be received in writing with a layout of the proposed alteration prior to publication. If approved, detailed reproductions must be identified as such in the credit line.
6. In providing access to a photographic image, the Museum does not surrender or otherwise limit its own right to publish it or to grant others access to the photographic image.

7. You will not use photographic materials to show or imply that the Museum endorses any commercial product or enterprise, concurs with the opinions expressed in, or confirms the accuracy of any text used with the said materials.
8. If provided, you will return all photographs, negatives, copy prints, and any other materials which replicate the image to the Museum after publication, with a complimentary copy of the publication, motion picture, videotape, disc, and/or other format, for our collection. This does not apply to materials provided by CD, DVD, or via email. You must notify the Museum in a timely manner of initial publication, broadcast, or public screening dates of the project for which the images have been used.
